**Member of the Spanish Delegation** for the defence of the Report before the Committee in Geneva (Switzerland). In their Final Observations to the Spanish State in 2010, the Committee compiled numerous contributions from the Chapter.

In 2016, he supervised the **Complementary Report for the United Nation Committee on the Rights of the Child for the follow-up of the implementation of the Optional Protocol to the Convention on the Rights of the Child in relation to the sale of children, child prostitution and the use of children in pornography.**





He has participated in the preparation, follow-up and assessment of the **I and II National Strategic Plan for Children and Adolescents (PENIA)** and **II and III National Plan against Sexual Exploitation of Children and Adolescents (PESIA)**; he is the Secretary of the **Organizer Committee** of the International Congresses on Child Abuse; as the developer of the activities of the **“Justice and Childhood” Program** -in the framework of the activities of the **“Child-friendly Justice” Program of the Council of Europe**- he has coordinated diverse Forums and reports which have had a significant impact on the **reform of the legal framework for children** in the 2010-2015 period. Since 2011, he has been the coordinator in Spain of the **European Council Campaign for the prevention of Sexual Violence against Children “One in five”** and he is the developer of the Network for Preventing Child Sexual Abuse - an experience for which he was invited to the **Capacity building workshop “Successful campaigning to stop sexual violence against children in the Council of Europe member states”** (Council of Europe, Strasbourg, France, 5-6 September 2012)-; Speaker and consultant in the **International Conference “Preventing Child Sexual Abuse”** co-organized by the Council of Europe and the Government of Spain (Madrid, December 2013).
